- Improved a major medical device manufacturer's bottom line by over \$2.25M annually during a three-month part-time consulting contract by updating, streamlining and optimizing their entire accounting system. This included replacing SAP ERP software with Net Suite, and the automation of many tedious tasks via Microsoft Excel, Macros and MS SQL. *Overall productivity was increased by 100%.*
- Selected by CEO for promotion to Director of Accounts payable in 2002, where my mission was turning an archaic paper-based accounts payable department into a paperless computerized system. The accounts payable and the inventory control departments were merged to enhance reconciliations, audits and accuracy, which reduced losses, resulting in a \$175,000 savings annually.
- Partnered with the Information Technology team to design, develop and implement a complex electronic data interchange (EDI) gateway in 2003, while working for Costco Wholesale Corporation, which sells over \$5.5 billion annually. This effort generated over \$798,000 worth in net savings annually as after completion only three people are required to do the work verses the former staff of 27.
- Challenged with a majority of business clients transitioning from invoices that were paid in 15 days to invoices that were paid in 60-90 days because of the financial crisis in 2008-2009, a two percent late fee per month was implemented for all late payers to account for CWC's lost interest and encourage more predictable cash flow. Initiating and implementing this policy *saved over \$3.4M annually*.
- Created, developed and rolled out a new four-way match accounts payable system, which maximized accuracy for the accounts payable department and minimized the cost of processing vast quantities of invoices. After slowly phased in over 12 months, this system allowed for the automated processing of over 4.5 million invoices annually saving Costco Wholesale Corporation more than \$4,725,000 per year in labor and overtime expense.
